ADJUDICATORY HEARING

The adjudicatory hearing was called to order by Chairman Goll at 6:05 p.m. on February 8, 2007 at the Etna Township Hall. The meeting was audio and video taped for township records. Mrs. Weber, Mr. Cox, Mr. Goll, Mrs. Rogers, Mr. Johnson, and clerk Laura Brown were present.

The purpose of this hearing is to consider an appeal number 3824 concerning the Zoning Inspector's decision that a new zoning permit be filed was submitted by Scott Hayes representing Freda, William, and Barbara Langel for the property located at 8941 Hazelton-Etna Road, Pataskala, Ohio 43062. The nature of the appeal is to dispute the Zoning Inspector's decision regarding a zoning permit can not be amended.

David Goll explained how the hearing would be conducted.

Robert Meyer, Jr. with Porter, Wright, Morris and Arthur has been in discussion with the township's attorney. They wish to hold the hearings at a later date. Upon request of the Appellant, and with consent of Appellee, the Adjudicatory Hearings on the Appeals are hereby continued until a request for hearing is made by Appellant or the expiration of 90 days from February 8, 2007.

Because the Appeals remain pending for consideration, pursuant to Section 511 of the Etna Township Zoning Resolution, the expiration date for Zoning Permit 3517, established by Section 304 of the Etna Township Zoning Resolution, is tolled from December 15, 2006, the date of the filing of Appeal Number 3824, until both Appeals are resolved. IT IS SO ORDERED.
