The Etna Township Board of Trustees met on November 1, 2005 in the Etna Township Hall to hold a regular meeting. The meeting was called to order at 7:00 p.m. by President Burkholder and the pledge of allegiance was recited.

Roll call showed Mrs. Siddens, Mr. George, President Burkholder and the clerk present.

#### ADOPTION OF THE AGENDA

Mr. George moved to adopt the agenda. Siddens seconded. Roll Call: Siddens, yes; George, yes; Burkholder, yes.

#### ADOPTION OF THE MINUTES

Mrs. Siddens moved to adopt the October 18, 2005 meeting minutes. George seconded. Roll Call: Siddens, yes; George, yes; Burkholder, yes.

Mr. George moved to adopt the October 22, 2005 special meeting minutes. Burkholder seconded.

Roll Call: Siddens, abstain; George, yes; Burkholder, yes.

#### PUBLIC COMMENTS

Tom Dixon, 8467 Hazelton-Etna Road, said he would like to see a fire truck use the Longwood Crossing emergency access road to make sure the road has been properly engineered.

Mr. George said he would contact the fire department to make sure the fire trucks would be able to make the turn. President Burkholder suggested that he and Mr. Dixon attend the next fire board meeting and ask for a detailed explanation and if the turn from US 40 is feasible.

President Burkholder said he was on the subdivision review committee and they are reviewing the subdivision regulations as result of Cameron Chase and the zoning inspector's refusal to sign the final plat. The county is no longer going to require the zoning inspector's signature on final plats; feels this is usurping power from the township and believes that the county commissioners will not stop this movement.

Neil Ingle asked how parking in cul-de-sacs could be alleviated; this is a safety issue, fire trucks would be unable to reach a burning house.

#### PUBLIC HEARING

Section 909 Local Business to add Restaurant Carryout/Take Out and Restaurant Sit Down under permitted uses and to add Banquet Facility under conditional uses.

At 7:15 p.m., Mrs. Siddens moved to open the public hearing for Section 909 Local Business to add Restaurant Carryout/Take Out and Restaurant Sit Down under permitted uses and to add Banquet Facility under conditional uses and to add to the definitions section. George seconded. Roll Call: Siddens, yes; George, yes; Burkholder, yes.

President Burkholder read the zoning commission's recommendation, by a 3-0 vote, to approve the text amendments. LCPC staff and commission recommended approval of Article II and to conditionally approve Article IX with the condition that the definition of <u>Restaurant</u> <u>Carryout/Take out</u> should exclude Drive-Thrus.

Mrs. Siddens said she had concerns with placing drive-thrus and carryouts in local business and the way the amendment came about. Trustees should not be looking at changing amendments for a specific property but should consider the good of the entire community.

President Burkholder said he had mixed feelings. He would like to see restaurants in LB but has concerns about many sections in the zoning resolution. He would like to see a professional hired to rewrite the entire zoning code. New businesses should be established in the proper place instead of trying to rewrite the zoning resolution to accommodate a piece of property that is under contract.
