The Etna Township Board of Trustees met on January 17, 2006 at the Etna Township Hall to hold a regular meeting. The meeting was called to order by President Burkholder at 7 p.m. and the pledge of allegiance was recited.

Roll call showed Trustee Burkholder, Trustee Knapp and Fiscal Officer Digel-Barrett present. Trustee George was absent.

The motion to adopt the agenda was made by Mr. Knapp, seconded by President Burkholder. Knapp moved to add item F. - employee evaluations under new business, Burkholder moved to add #6 under Item E – deed restrictions and Item G. – John Q. Public letter under old business. The motion and amendments both passed unanimously.

ADOPTION OF MINUTES

President Burkholder moved to adopt the limited December 19, 2005 minutes (lack of quorum to hold meeting), Knapp seconded, the vote in favor was unanimous.

President Burkholder moved to adopt the limited December 20, 2005 minutes (lack of quorum to hold meeting), Knapp seconded, the vote in favor was unanimous.

Minutes for the January 3, 2006 meeting, were not ready and tabled.

PUBLIC HEARING

At 7:15 p.m. Mr. Knapp moved to open the public hearing on the zoning text amendment to Section 809, Local Business District and Section 810 General Business regarding marginal strip developments and Article 2 definitions. Burkholder seconded, the vote in favor was unanimous.

The text amendment change is to delete the last sentence "Marginal Strip development shall be prohibited" in Section 809, Local Business District (LB) and to delete the sentence "Marginal Strip development shall be prohibited" in Section 810, General Business District (GB)

Licking County Planning Commission (LCPC) and staff recommended approval of the text amendment and also recommended that a definition of shopping centers be included. An example was provided. The Etna Township Zoning Commission voted 5-0 to recommend approval of the text amendment and to include the definition for shopping centers.

Jin Van Dyne, 7173 Refugee Road, said the zoning commission is asking for removal of "strip mall" because a definition could not be found. Phil Laurien with Delaware County Regional Planning Commission also suggested removal of "strip mall".

At 7:27 p.m. Mr. Knapp moved to close the public hearing, Burkholder seconded, the vote in favor was unanimous.

Resolution 06-01-17-01: Mr. Knapp moved to accept the recommendation of the zoning commission to delete the last sentence "Marginal Strip development shall be prohibited" in Section 809, Local Business District (LB) and to delete the sentence "Marginal Strip development shall be prohibited" in Section 810, General Business District (GB) and to add the ddefinition for shopping centers. Burkholder seconded, Roll Call: Knapp, yes; Burkholder, yes.

At 7:30 p.m. Mr. Knapp moved to open the public hearing on the zoning text amendment to Section 510 Appeals, Section 513 Application and Standards for a Variance and Article 2 Definitions. Burkholder seconded, the vote in favor was unanimous.

Inspector. Such appeals shall be taken by filing with the Zoning Inspector and the Board of Zoning Appeals, a notice of appeal specifying the grounds upon which the appeal is taken. This notice must be presented at the Etna Township Hall to the Township Clerk or Zoning Inspector by the close of normal business hours on the twentieth (20th) day after the decision. In their absence, the notice may be administratively received by a Township Official. The Zoning Inspector shall transmit to the Board of Zoning Appeals all the papers constituting the record upon which the action is appealed.

Section 513 Application and Standards for a Variance - proposed change is to switch the current statements from #4 with the statements from #5

Article 2 - Definitions

Aggrieved Person: An aggrieved person is one whose interest in the matter is immediate and/or pecuniary, and not a remote consequence of the judgment. (Pecuniary is defined as relating to money.)

LCPC and LCPC staff recommended approval and the Etna Township Zoning Commission voted 4-0 for approval.

David Goll, 8995 York Road, said the BZA recommended the changes as a housekeeping measure. The submission of the appeal sets a definite deadline. The definition of aggrieved person was added to prevent frivolous appeals and one made for spite.

Mr. Knapp questioned how "interest in the matter is immediate and/or pecuniary, and not a remote consequence of the judgment" would be interpreted.

Dallas Maynard said the appeal must have merit and must be decided by the BZA if the appeal has merit.

President Burkholder also questioned how "remote consequence of the judgment" would be interpreted. The definition is still vague. If an appeal was not heard by the BZA, would the person still be able to appeal in common pleas court. The BZA would be given too much power in making the determination.

Mike Waller said the five members of the BZA would determine if the appeal has merit and if the appeal is not heard, then the person has recourse in the courts.

At 8:15 p.m., President Burkholder moved to recess the public hearing until the February 7th meeting. Knapp seconded, the vote in favor was unanimous.

PUBLIC COMMENTS

Jim Van Dyne questioned the 1.5 mill road levy on the agenda. Burkholder explained the levy would generate approximately \$510, 650 per year for 5 years. This would include the residents of the incorporated section of the township. Van Dyne questioned what would stop Reynoldsburg from annexing Taylor Road if the township paid for its improvement. Burkholder replied that the Reynoldsburg residents would also be paying for the road and the road will be safer for use by the unincorporated residents of the township. Van Dyne questioned why WalMart was not helping to pay for the road since most of the traffic was going to the store and shopping area. Burkholder said he would be willing to elicit financial support from the businesses in Taylor Square.

Claudette Van Dyne, 7173 Refugee Road, asked what guarantee there would be that the money from the levy would be used to improve Taylor Road. Burkholder replied that he would check with the prosecutor's office concerning this.

At 8:40 p.m., a motion was made and passed for a five minute recess.

WHEREAS, this Board finds that the amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of Etna Township and it is necessary to levy a tax outside the ten-mill limitation; and

WHEREAS, pursuant to Division (B) of Section 5705.03 of the Revised Code, this Board must request certified information from the Licking County Auditor before submitting the question of a tax to the electors.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Etna Township:

Section 1. This Board declares that it is necessary to levy a tax outside of the ten-mill limitation for the purpose of general construction, reconstruction, resurfacing and repair of streets, roads and bridges in Etna Township as authorized by Section 5705.19(G) of the Ohio Revised Code, and that it intends to submit the question of the addition of that levy to the electors at a primary election on May 2, 2006.

Section 2. This Board requests the Licking County Auditor to certify to it both (i) the total current tax valuation of the Township and (ii) the dollar amount of revenue that would be generated by a 1.5 mill additional levy.
