The Etna Township Board of Trustees met on Saturday, March 17th, 2012 in the Etna Township Administration Building. The meeting was called to order at 9:00 a.m. by President Carlisle. Jeff Johnson led the invocation and Kyle Smith led The Pledge of Allegiance. The roll call showed Trustees Jeff Johnson, John Carlisle, Randy Foor, and Fiscal Officer Walter Rogers present.

Trustee Johnson moved to adopt the agenda as presented. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

Trustee Carlisle moved to approve the March 6th, 2012 regular meeting minutes. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

Licking County Sheriff's Department, Deputy Nick Pease and Captain Dave Starling

Captain Dave Starling likes to have his detectives interacting with the community. Deputy Nick Pease discussed the RAIDS online feature that is available on the Licking County website in the Sheriff's section. The Sheriff's office serves with the public. The community and Sheriff's Department need to work together. Community Block Watch programs help the Sheriff's office to serve the community. The RAIDS online program is free to everyone. Within the area serviced by the Sheriff's Office, Etna Township is the smallest township with the most population. If you go by the per capita crime statistics Etna Township is one of the lowest at .17, Harrison Township is .24 and Licking Township is .51 for 2011. Captain Dave Starling stated most of the burglaries are traced back to Columbus. Deputy Nick Pease discussed an individual's right to protect themselves. Bruce Hennick of the Police Committee will work with Captain Dave Starling on crime statistics. Deputy Nick Pease stated a non-priority (burglar alarm/false alarm) call averages a ten minute response time. A panic alarm will register a priority call and the response time is quicker. A resident can go to www.radioreference.com under live audio to listen to the police monitoring via the computer like a scanner. Deputy Nick Pease stated the Block Watch programs use the radio reference website.

Trustee Foor said that Deputy Nick Pease has been a good resource to our communities. Trustee Carlisle said that Deputy Pease has responded to all of his issues or concerns.




Announcement and Trustee Comments
