WHEREAS, Ohio Revised Code §5577.07(B) authorizes the county commissioners to reduce the weight limits on roads or highways as the condition of the road or highway justifies; and

WHEREAS, the Board of Trustees of Etna Township, Licking County Ohio, has determined the following list of roads, in their entirety, to be in need of the maximum weight of vehicle reduction:
