The Etna Township Board of Trustees met on June 20, 2005 at the Etna Township Hall to hold a regular meeting. President Burkholder called the meeting to order at 7:00 p.m. and the pledge of allegiance was recited.

Roll call showed President Burkholder, Trustee Knapp, Trustee George and Fiscal Officer Digel-Barrett present.

The motion to adopt the agenda was made by Mr. George, and seconded by Burkholder. President Burkholder moved to amend the agenda to add under old business, Item M – request for representation at hearing. George seconded the amendment and the vote in favor of the amendment and motion was unanimous.

ADOPTION OF MINUTES

Mr. George moved to adopt the June 6, 2006 meeting minutes, seconded by Burkholder.

Discussion: Mr. Knapp said for the record, the statement in President Burkholder's memorandum that Ms Brown was told by George and Knapp that the e-mail was not to be released was incorrect. President Burkholder said he stands by the information in the memo.

Roll Call: Burkholder, yes; George, yes; Knapp, yes

PUBLIC COMMENTS

Dan Bravard, 10252 Taylor Road, had questions on the water line that will be installed on Taylor Road such as when it was approved, will the residents be notified, will property owners be compensated for damages and when will the right-of-ways be mowed. President Burkholder said the project was approved in May and the mowing will be done when the road is closed as well as preconstruction work before the pavement project begins.

Delores Trevitt, 10371 Taylor Road, said that surveying work was done from the school going south, not north. Mr. Waller confirmed that the water line is going south from the school, 480' to New Taylor Road.

Jim Van Dyne, 7173 Refugee Road, informed the Board that a band with a reputation for destruction will be performing at Frontier Ranch around July 13th and suggested that the Licking County Sheriff's office be notified.

PUBLIC COMMENTS, continued

Ken Jacks, Palmer Road, asked if this morning's special meeting was advertised in the paper. President Burkholder replied that it was not advertised but the media was contacted and two different agenda's were posted. Jacks replied that the meeting was scheduled two weeks ago and a 9 AM meeting is not convenient for people who work. Mr. George said he could not attend because of a health issue and Mr. Knapp said he had an emergency.

There was discussion on the legality of the meeting, posting of agenda by the chairman and not the trustee requesting the meeting. President Burkholder did not reply to Knapp's e-mail about the special meeting agenda and request for additions or corrections and notice that if there were none, then the agenda would be posted on Friday. Burkholder said his agenda with specific items was posted on Sunday morning and was later removed. Burkholder alleged that Knapp and George viewing Taylor Road together was an illegal meeting and George replied, for the record, "Mr. Knapp and I never had a meeting on discussion of Taylor Road." Mr. George said he was showing Knapp where Taylor Road was at and the measurement of the road.

Neil Ingle, 71 Trail East, asked Mr. Knapp if he made the comment "as soon as Paul George gets back, Gary Burkholder is going to be on the outside looking in". Knapp replied that the statement was absolutely false.

Tom Dixon, 8467 Hazelton-Etna Road, said that trees were planted in the water and utility easement in Cameron Chase and some branches are hanging over his property. The zoning inspector told him to contact the county engineer. The tile problem has not been corrected. President Burkholder said the zoning and building issues need to be complied with.

Resolution 06-06-20-02: President Burkholder moved to suspend the issuance of building permits in the final phase of Cameron Chase until such time as we get some resolve or some answers on this problem. George seconded.

Discussion: President Burkholder said Mr. Maynard did not sign the final plat but it was signed by the three county commissioners.

Roll Call: Burkholder, yes; George, yes; Knapp, yes

David Weber, 232 Purple Finch, said he had submitted zoning sign violations to the zoning department that have not been acted upon even after a press release stating that violations would be acted upon. Mr. Weber said he had a problem with the availability of public records and that all records should remain at the township hall.

Ken Jacks said he was told that the zoning inspector is too busy to handle all of the violations but according to his calculations, in 2001 when there was only a part time zoning inspector, more permits on average were written per month than this year.

Delores Trevitt said the trustees should show respect for each other and work together. Unprofessional conduct and disagreements splits township residents against each other. The residents need the trustees' promise of working together.

Jim Van Dyne said he believes the trees Mr. Dixon referred to are in the buffer area.

Interviews and appointment for zoning commission

Mr. Knapp explained that in the motion to advertise for the vacancy, the deadline for submission was June 5th but when the ad was placed in the newspaper, the date was stated as June 20th. Two applications, Trent Stepp and Dan Bravard were received by June 5th and two applications, Pam Munce and Randy Snyder were received by June 20th. The trustees agreed to accept all applications by the advertised date of June 20th.

Trent Stepp said he presently serves as an alternate member and is a strong advocate for planned zoning and is opposed to spot zoning. He believes that the township should control the growth, not the county commissioners and that SR 310 can not sustain more growth until the infrastructure is in place.

Dan Bravard said he has served the township for twenty years, is independent of special interest groups and persons, and will remain so, has no axes to grind, does not lie and is concerned about the entire township.

President Burkholder said he believes Mr. Bravard's philosophy and attitude towards Reynoldsburg is negative. Mr. Bravard replied that he is concerned about Etna Township. Reynoldsburg should not control our township, continue expanding into our township and taking our way of life away from us.

President Burkholder said Mr. Bravard supported additional GB zoning on SR 310 which is not the same as his philosophy. The appointment is political and he basis his appointments on his philosophy on the development of the township.

Pam Munce said she would like to help with the development of the township and sees the need for cooperation with the neighboring communities. She supports retail but in the proper location and commented that distribution buildings with truck bays should not be built directly on Route 40, but located in the back of the industrial park.

Randy Snider, a lifelong Etna resident, is concerned about the community and wants to make it the best place possible for his family and all other residents. He would like to see the township work with the

State and developers to move the access into Wal-Mart from SR 310 to Route 40. Mr. Snider was for the rezoning of the back portion of the Langel property to GB for Wal-Mart.

President Burkholder said he had a problem with supporting anyone on the zoning commission who approves of the overdevelopment of SR 310.

President Burkholder said he would like for the Board to consider closing Taylor Road, except for local traffic, the same time that Reynoldsburg is closing the south portion of the road.

Resolution 06-06-20-03: President Burkholder moved to close Etna Township's portion of Taylor Road both north and south of Palmer Road to coincide with Reynoldsburg's closure for road repair and paving. Knapp seconded.

David Goll said the district purchased land from the Pataskala Lion's Club, at the ballpark for a future substation in exchange for their water assessment. Mr. Frommer is putting together a questionnaire for Taylor Road residents on the cost of extending water to them. The district is having a problem with rust in the water and will need to update some equipment.
