The Etna Township Board of Trustees met on July 6, 2006 at the Etna Township Hall to hold a regular meeting. President Burkholder called the meeting to order at 7:00 p.m. and the pledge of allegiance was recited. Roll call showed President Burkholder, Trustee Knapp, Trustee George and Fiscal Officer Digel-Barrett present.

The motion to adopt the agenda was made by Mr. George, seconded by Knapp. Mr. Knapp moved to place items C & D under new business, to item B under public comments. George seconded and the vote in favor of the amendment was unanimous. President Burkholder moved to add under new business, item L-OTA state and national conferences and item M-community communications. George seconded and the vote in favor of the amendment was unanimous. Mr. Knapp moved to place item F, under new business, to the fiscal officer's report. George seconded and the vote in favor of the amendment and motion was unanimous.

ADOPTION OF MINUTES

Mr. George moved to adopt the June 20, 2006 meeting minutes. Knapp seconded and the vote in favor was unanimous.

PUBLIC COMMENTS

John Campbell, 301 Hawthorne, said he did not have a water problem; questioned the need for a ditch petition; said the residents are being assessed out of their development and the property owners effected by the water problem should be responsible not the other residents.

Colleen Rice, 68 Jonquil Drive, said she does not have a water problem and that the trustees should check Longwood Crossing where she believes trees were shoved into the ravine causing a change in the water flow. This problem was caused by the developers and the residents should not be charged.

Jim Duffy, 27 Daisy Drive, said homeowners have filled in ditches and a previous ditch petition effort was defeated.

Delores Trevitt, 10371. Taylor Road, had questions about extension of water and sewer down S. Taylor Road.

Darlene Cheek, 11 Third Avenue, asked when a decision would be made on the cross walk and was told probably tonight.

Leroy Wilbur, 10 First Avenue, said he was in support of the cross walk for the church.

Dennis Rider, 9238 Hazelton-Etna Road, spoke about alleged deceptive practices of Maronda Home sales people and shoddy workmanship. He wants the trustees to bring Maronda Homes under control and believes the developer is giving the township a bad reputation.

David Weber, 232 Purple Finch Loop, said that LCPC subdivision regulations require that all PUD's have homeowner's associations where there is green space.

Dee Dunlop, 970 Columbus Street, asked about the presence of law enforcement on US 40 and SR 310 for the upcoming concert at Frontier Ranch and was told about the planned security by the promoter and Licking County Sheriff's Office.

Shawn Hoytsik, 26 Laurel Drive, said he is against the ditch petition and that the lot size for the Maronda Homes need to be investigated; believes that the size is smaller than allowed.

Jim Campbell said his home abuts Frontier Ranch and the fence behind his property was removed and this area needs to be patrolled

Claudette Van Dyne asked if the fire department will be enforcing the no burn law and was told yes.

Tom Dixon, 8467 Hazelton-Etna Road, spoke about the trees in the easement at Cameron Chase blocking drainage and wants the building permits stopped.

Kim Pennington, 113 Brenden Park Drive, believes that the Licking County Commissioners do not care about the Etna Township residents, evidenced with the Wal-Mart project and urged citizens to vote for change.

Deborah Calovini, 411 Trail West, said the residents should not have to plead their case to the trustees but it should be the developer requesting permission to build a quality development.

Cheri Rogers, 62 Nantucket, said that resident involvement is crucial to prevent problems from developing years later.

Presentation of Qualifications for Etna Comprehensive Plan

Jeffrey Stromm with EMH&T briefly explained what his company could do and requested to return when the trustees would have more time.

Christopher Hermann, planning director with MSI, talked about how his company could help the township with planning.

New Business, Items C & D regarding interviews for zoning inspector

Mr. Knapp said the trustees could interview applicants for the zoning inspector in executive session and proposed a special meeting to do so. According to Eric Fox, Assistant Licking County Prosecutor, the agenda could not be amended for the correct reason for the executive session.
