The Etna Township Board of Trustees met on October 3, 2006 at the Etna Township Hall to hold a regular meeting. President Burkholder called the meeting to order at 7:00 p.m. and the pledge of allegiance was recited. Roll call showed President Burkholder, Trustee George and Fiscal Officer Digel-Barrett present. Trustee Knapp was absent.

The motion to adopt the agenda was made by Mr. George, seconded by Burkholder. Mr. George moved to amend the agenda to add under new business, item E – Extend probationary period for new employee for 30 days. Burkholder seconded and the vote in favor of the amendment and motion was unanimous.

ADOPTION OF MINUTES

Mr. George moved to adopt the September 19, 2006 meeting minutes, Burkholder seconded for discussion. President Burkholder stated the minutes did not accurately reflect the comments made at that meeting. President Burkholder specifically asked questions about whether a road from the bank to Cumberland Trail was discussed at the December 7, 2005 TRC meeting and Mr. George had responded that it was not discussed at that meeting.

Mr. George said that at the September 19th meeting, he had said that he did not remember.

President Burkholder moved to table the adoption of the minutes and there was no second to the motion. President Burkholder requested that the fiscal officer put into the record as to who said what. Mr. George said he did not remember but he did state at the TRC meeting that there would be a lawsuit if the bank pursued a road cut to Trail East.

President Burkholder reviewed the format for public comments.

PUBLIC HEARINGS

B. Section 1401 Definition of Junk Motor Vehicle

At 7:15 p.m., Mr. George moved to open the public hearing. Burkholder seconded and the vote in favor was unanimous.

Proposed text amendment:

"For the purpose of this section, "junk motor vehicle" means any motor vehicle, which meets any or all of the following:

- 1. Without current license plates and registration or
- 2. Extensively damages, such damage including but not limited to any of the following: missing wheels, tires, motor, or transmission or
- 3. Apparently inoperable, that is left uncovered by not being housed in a garage or other suitable structure, in the open on private property for more than seventy-two (72) hours with the permission of the person having the right to the possession of the property, except if the person is operating a junk yard or scrap metal processing facility licensed under the authority of Section 4737.05 to 4737.12 of the Ohio Revised Code; or regulated under other sections of this zoning resolution."

Burkholder read the Licking County Planning Commission (LCPC) and LCPC staff reports. Conditional approval was given and one condition was the addition of "meets any or all of the following:" which was incorporated into the recommendation given to the trustees. Second condition was to receive a legal opinion in regards to the township's authority to regulate junk motor vehicles within their zoning resolution.

John Jones asked if "suitable structure" was up to the interpretation of the zoning inspector and said he did not want any interpretation left to the zoning inspector and was against the amendment.

Joe Wagner, 179 Beechwood Dr, said he was against the amendment and did not feel the interpretation of structure should be left up to the present zoning inspector.

John Cowan, 128 Beechwood Dr, said the word structure has many different meanings and was against the amendment.

At 7:23 p.m., President Burkholder moved to recess the public hearing until October 17th at 7:15 p.m. George seconded and the vote in favor was unanimous.

A. Add Section 1035 Accessory Structures

President Burkholder said the amendment was deficient and he could not support it the way it was written. Mr. George said he agreed with President Burkholder

Resolution 06-10-03-01: Mr. George moved to deny the recommendation from the zoning commission to add Section 1035 – Accessory Structures to the zoning resolution. Burkholder seconded. Roll Call: Burkholder, yes; George, yes

PUBLIC COMMENTS

A. Proposed roadway onto Trail East from The Pataskala Banking Company site; motion to approve additional funds for Chester, Wilcox and Saxbe.

Gary Godwin, 63 Trail East, said that at the last meeting, Mr. George said the roadway to Trail East was not mentioned at the LCPC meeting. Mr. Godwin said he listened to the 12/07/05 tape of the LCPC meeting and there was a 30 minute discussion on the bank property and the majority of the discussion was about the roadway. Lying is grounds for resignation or removal from office.

Kathy Johnston, 254 Trail East, said the 3/27/06 LCPC minutes were referenced at their meeting last week. Jerry Brems commented that the staff is proposing that the Pataskala Banking Company work with Columbia Trial Golf Course Ltd. to swap enough land for the driveway and to widen the strip by the appropriate square feet so they can have a trade off to keep the exact square footage of open space. When Mr. Brems asked the Board if they would like for staff to proceed with this option, there were no comments made by the Board. Mr. Brems also stated, that in formal discussion, two of the Etna Township trustees agreed that the LCPC staff should move forward to continue to look at this as an option. When asked by Ms. Johnston, President Burkholder and Mr. George both denied giving LCPC permission to pursue the road cut for the bank.

Ms. Johnston said the trustees need to immediately pass a resolution calling for Jerry Brems resignation because he lied to LCPC. And in the absence of his resignation, the county commissioners and LCPC should terminate his services.

Resolution 06-10-03-02: President Burkholder moved that the Board of Trustees immediately send a letter to the Licking County Commissioners and the Licking County Planning Commission demanding the immediate resignation of Jerry Brems, director of LCPC, and that if he refuses to resign, that he be terminated as soon as possible. George seconded.

Discussion: Mr. George said the recommendation by LCPC is not binding on the township. President Burkholder said that Brem's signature is on a construction plan that shows an access road to Trail East as of 9/5/06 and asked who gave the authorization. President Burkholder will write the letter and Mr. George will also sign it.

Roll Call: Burkholder, yes; George, yes

Carl Anston, 11 Milkweed Place, said he listened to a tape of the meeting and that Mr. George did not specifically say that he would not support the access road and that George has a fiduciary responsibility to represent the residents of Cumberland Trails and if he can not do so then he should resign.

Dave Pollock, 259 Trail East, said he did not come to the meeting to listen to the trustees arguing, the trustees need to tell him what they are going to do to stop the access road.

Gil Guttentag, 70 Trail East, said his interpretation of the 12/7/05 tape was that when Mr. George said that there would be a lawsuit, that the lawsuit would be brought by another trustee and he (George) passively agreed to the road access.

Kim Pennington, 113 Brandon Park Drive, said she heard on the tape that Mr. Brems said that they only need two of the trustees to agree.

Resolution 06-10-03-03: President Burkholder moved to approve an additional \$20,000 in legal fees for Chester, Wilcox and Saxbe to preserve the green space and reserve space of Cumberland Trails and every PUD within the entire township. George seconded

Discussion: Mr. George said the county was going to consult the prosecutor and questioned if there had been a response. President Burkholder said the county will drag their feet until the bank files legal action. George asked who the township would file suit against and Burkholder said if the bank does not honor the stop work order, then the injunction will be against the bank.

Roll Call: Burkholder, yes; George, yes

David Pollock asked what Paul George was going to do for the residents of Cumberland Trails. George responded anything it would take including a lawsuit against the county.

Chris Cirotto, 24 Dellenbaugh Loop, said Cumberland Trails is the crown jewel of the area and needs to be protected. He has a started a petition to boycott the Pataskala Bank. For the record the petition reads: "We the undersigned residents of Pataskala, Ohio do hereby promise to boycott The Pataskala Banking Company, (including all of their locations). This boycott is effective immediately upon signature of this petition. This boycott will stay in effect until The Pataskala Banking Company changes any and all current and future plans that relate to installing an access road running through the Cumberland Trails reserved green space to dump commercial traffic into our residential neighborhood(s) via Trail East." Seventy two signatures have been collected so far.

President Burkholder said this was no accident and was a purposeful attempt to circumvent the process of coming back to the zoning commission and the trustees. On the 12/7/05 tape, Mr. Brems said if the access road to Trail East is not obtained, then the bank will have a right-in and right-out access only. Mr. Brems has pushed this access road from the beginning and the bank has been a willing participant.

Neil Ingle said when the rezoning to PRO was before LCPC, it was stated that there was adequate access to the roadway. But the Friday before, Brems sent an email to Scott Hayes, attorney for the bank, raising concerns over the rezoning. Brems wrote that one option would be to gain access from Trail East over the reserve area.

President Burkholder said when the Etna Township Zoning Commission approved the rezoning to PRO, the access point to Trail East was not included. When the rezoning came before the trustees, he voted against the rezoning because the township did not have the assurance that there would be no roadway to Trail East. This is a conspiracy against the township from the previous zoning inspector to the county commissioners.

Gil Guttenberg said the bank parking lot will be lit 24/7 because of the ATM and it is time for a light ordinance.

John Jones said there were two separate bids, one for the bank and another for the roadway, so they knew from the beginning that there would be an access road.

Chris Ciotto said the trustees need to send out notices to the residents to attend the meetings.

Brandie Brown, 30 Runkle Drive, asked if the roadway would run to Buckeye Mulch and if there was specific zoning concerning the distance from adjoining properties.

John Cowan said he would not withdraw his money from the Pataskala Bank if he had money there, thinks Mr. George is a respectable man and said the Cumberland Trails residents should realize that SR 310 will get even more traffic and suggested a wall between the businesses and residential properties.

John Echlar, 372 Trail East, wanted clarification that an attorney would be hired.

David Goll, 8995 York Road, said he did not get a copy of the disc from the LCPC meeting but it seems like the discs were passed around to Cumberland Trails residents with the intention of beating up on Mr. George. Etna Township is made up of more than just Cumberland Trails and Mr. George has done an excellent job in defending all of Etna Township residents not just Cumberland Trails.

President Burkholder said Mrs. Brown could provide Mr. Goll with a copy of the CD.

David Wilder, 52 Dellenbaugh Loop, asked if the reserve is classified as open space and said as open space it can not be sold as it was for \$15,000.

Dave Pollock asked if the township had a lighting ordinance and if not, then one should be done.

John Jones said his landfill operation was approved by the county and the EPA and he brought the documentation to the township. The zoning inspector visited his site, took pictures and called the EPA. Mr. Jones asked that the zoning inspector be terminated.

Joe Wagner said he submitted a written complaint about an employee and nothing has been done. Feels the zoning inspector is being protected and should be fired for dereliction of duty.

At 8:43 p.m. a recess was called.

B. Discussion of SR 310 Tax Increment Financing (TIF) and the joint meeting in October with Pataskala City Council

Resolution 06-10-03-04: Mr. George moved to support a TIF, Burkholder seconded.

Discussion: President Burkholder said he has not received any documentation from the SWL School Board and does not know how Mr. Knapp stands on this issue. Burkholder would like to see Pataskala earmark 40 to 50% of their TIF money for the I-70 and 310 interchange and adopt a responsible growth and development plan for the SR 310 corridor. Big box stores on SR 310 is not in the best interest of either community.

Mr. George moved to amend his motion to proceed forward with the TIF for SR310 and to contact SWL schools for their views on the TIF if Mr. Knapp has not already done so. Burkholder seconded. Roll Call on amendment: Burkholder, yes; George, yes
