The Etna Township Board of Trustees met on August 7, 2007 at the Etna Township Hall to hold a regular meeting. President Knapp called the meeting to order at 7:04 p.m. and the pledge of allegiance was recited. Roll call showed President Knapp, Trustee Burkholder, Trustee George and Fiscal Officer Digel-Barrett present.

The motion to adopt the agenda was made by Mr. George, seconded by Burkholder. President Knapp moved to amend the agenda to add a presentation by Bernie Caplin and to remove items D and E under new business, Mr. Burkholder moved to add an executive session per O.R.C. 121.22 G(1) to consider the compensation of a public employee after the last public comment period. Burkholder seconded the amendment and the vote in favor of the amendment and motion was unanimous.

ADOPTION OF THE MINUTES

Mr. George moved to approve the July 6, 2007 special meeting minutes. Burkholder seconded and the vote in favor was unanimous.

Mr. George moved to approve the July 10, 2007 regular meeting minutes. Burkholder seconded and the vote in favor was unanimous

Mr. George moved to approve the July 11, 2007 special meeting minutes. Burkholder seconded and said the minutes should reflect that this was a special meeting, not a regular meeting. The vote in favor was unanimous with the correction.

PUBLIC COMMENTS

Neil Ingle, 71 Trail East, requested that the president explain the basic steps for forming a JEDZ and the cost to the township.

Wayne Wirth, 438 Trail West, asked if there was a JEDZ contract and if public hearings were held.

Gil Guttentag, 70 Runkle Drive, asked if a cost benefit analysis had been done on the financial and quality of life implications of the JEDZ as well as the Pataskala JEDD.

Gary Godwin, 63 Trail East, said the school boards and county commissioners have not yet voted on the tax abatements and questioned how the township could move forward.

Terry Bailey, 180 Trail East, asked if Item A under new business could be discussed now.

President Knapp said it could not and the above questions posed by residents would be discussed under item A under new business.

President Knapp said the wording for Item A is incorrect. What he meant to say is for the trustees to discuss taking it to the county prosecutor to see if we could have Etna residents vote on the issue to participate in the JEDD.

Major development presentation by Bernie Caplin of CapOhio

Mr. Caplin proposes to develop 113 acres at the southeast corner of Mink Street and Refugee Road for small to medium size businesses and another 179 acres on the east side of Smoke Road, north of US 40 for larger businesses. At this site, he plans to donate 70 acres abutting Watkins Memorial High School, to the school. About 8 acres are wetlands and the donation of land will save the school an estimated 4 million dollars. He is seeking 100 percent tax abatement for 15 years and would like to form a JEDZ and a TIF.
