Meeting

The Etna Township Board of Trustees met on November 20, 2007 at the Etna Township Hall to hold a regular meeting. President Knapp called the meeting to order at 7:00 p.m. with a moment for silent prayer and the pledge of allegiance was recited. Roll call showed President Knapp, Trustee Burkholder, and Fiscal Officer Digel-Barrett present. Trustee George was absent

The motion to adopt the agenda was made by Mr. Burkholder, seconded by Knapp and the vote in favor was unanimous.

ADOPTION OF THE MINUTES

Mr. Burkholder moved to approve the October 16, 2007 meeting minutes, Knapp seconded. Mr. Burkholder moved to correct the spelling on the last page of Dickson to Dixon. Knapp seconded the correction and the vote in favor of correction and motion was unanimous.

Mr. Burkholder moved to approve the November 8, 2007 meeting minutes, Knapp seconded. Discussion: Mr. Burkholder moved to add to the first paragraph on the fourth page to include his comment: "that Mr. Robinson had not been happy with the township because he was not given a pay raise". Mr. Burkholder felt that this statement was significant and was Mr. Robinson's motivation and intent for filing his grievance. There was no second to amendment.

Mr. Burkholder requested that the minutes of this meeting reflect his motion and comments. Roll Call: Burkholder, no; Knapp, yes

PUBLIC COMMENTS

David Goll, said the Board of Zoning Appeals is faced with a situation similar to fences. Before Mr. Robinson became zoning inspector, there was no enforcement of sign permits. Some signs have permits and some do not and said a solution is needed to handle old signs erected. Mr. Goll feels there will be a snowball effect with one BZA hearing after another and that the possibility of waiving the penalty fee for not obtaining a permit could be considered

Mr. Burkholder said ignorance of the law is no excuse.

President Knapp said that letters could be sent to all violators of the sign permit and if they comply, the late fee could be waived. If the violator does not comply, then the late fee could be charged.

PRESENTATION

Jan Rice and Vince Mazeika, with the Central District Office of the EPA were in attendance because the township plans to update the land use plan. They requested that the township consider the impact of development along waterways. The EPA is responsible for protecting water quality and streams and rivers in the state and the quality of life. Development should be restricted along streams and river corridors.

07-11-20-01: Mr. Burkholder moved to approve the expenditure of \$130.94 to Wheelsport for sharpening chains, bar oil and chains. Knapp seconded and the vote in favor was unanimous.

07-11-20-02: Mr. Burkholder moved to approve the expenditure of \$355.54 to Ace Truck Equipment for hydraulic pump and strobe lights for the International truck. Knapp seconded and the vote in favor was unanimous.

Zoning - written report submitted

Mr. Burkholder said he would not support a 20' setback. Regarding obstructions in the road right-of-ways, it is okay for the zoning inspector to write draft resolutions but the final resolution should be written by an attorney, the Licking County Prosecutor's Office.

MORPO

Mr. Burkholder said the Board will need to renew its membership with MORPC and thinks membership in this organization is worthwhile.

Water and Sewer

Mr. Goll said Kikersville is supposed to sign the water agreement and will be responsible for the infrastructure for the water lines on Route 158 to Flying J. The water and sewer board will bill Kikersville with one bill and they will be responsible for billing the customers. There will be no tap fees collected for the water lines on Route 158. New customers will be charged tap fees and the District will receive 90% of those fees.

OLD BUSINESS

A. Motion to appoint township record official Legal opinion has not been received from the Licking County Prosecutor

B. Update and discussion regarding ProLogis JEDZ II development and compensation agreement President Knapp said the township has not received the information regarding the compensation agreement.

Mr. Burkholder expressed concerns that ProLogis wants to move forward with the CRA agreements and other agreements before the JEDZ II or compensation agreement is completed. He does not think any of the JEDZ money should go back to the developer for infrastructure since the improvements are on their property and they are receiving tax abatements. The site plan does not show a path to I-70 and MORPC said an interchange will not be built there even though some county officials believe an interchange will be built. All the traffic from this development and the one in Pataskala will be funneled down Route 40. Mr. Burkholder would like to preserve the opportunity on this site to connect to I-70 and does not support 100% tax abatements and more warehousing.

C. City of Pataskala Refugee Road re-paving/reconstruction project update
There was discussion on the unanimous vote at the last meeting of approving up to \$10,000 to Pataskala
for the Refugee Road repaving project. Mr. Burkholder said according to Pataskala Councilman King,
the expense for addressing the drainage problem will not be included on the Issue I funding and will be an
add on project. Pataskala is supposedly spending an extra \$3600 for the drainage line to the
condominiums. Fixing the drainage is a safety issue and if the township does not help, then the drainage
issue will not be addressed because of Pataskala's budgetary constraints.

President Knapp said he thought the expenditure of \$10,000 was for supplies, that he township road crew would make the drainage repairs and that the money would not be given directly to Pataskala. He learned that the township has a maintenance agreement with Pataskala and Pataskala is responsible for this section of Refugee Road, not the township and said township money should not be used.

Mr. Burkholder said the expenditure of money was authorized on the contingency that Mr. Waller and Trustee George meet with Pataskala officials to see what will be accomplished. The paving project is under time constraints. President Knapp will contact Mr. King and the item will be on the next agenda.

D. Township employee vacation approvals

Mr. Burkholder moved to approve Mark Smith's vacation 12/24 through 12/31. Knapp seconded and the vote in favor was unanimous.
