The Etna Township Board of Trustees met on December 4, 2007 at the Etna Township Hall to hold a regular meeting. President Knapp called the meeting to order at 7:01 p.m. with a prayer and the pledge of allegiance was recited. Roll call showed President Knapp, Trustee George and Fiscal Officer Digel-Barrett present. Trustee Burkholder was absent due to illness.

The motion to adopt the agenda was made by Mr. George, seconded by Knapp and the vote in favor was unanimous.

### ADOPTION OF THE MINUTES

Mr. George moved to approve the November 8, 2007 meeting minutes. Knapp seconded and the vote in favor was unanimous.

Mr. George moved to approve the November 20, 2007 meeting minutes. Knapp seconded and the vote in favor was unanimous.

Mr. George moved to approve the November 30, 2007 special meeting minutes. Knapp seconded and the vote in favor was unanimous.

### **PUBLIC COMMENTS**

Dan Bravard, 10252 Taylor Road, said he would like to see a board placed in the new township hall with a list of all the trustees who served the township since the beginning. He would be willing to serve on a committee to do research but would be unable to do it alone.

Mark Schaff, 7461 National Road, said "big box" stores belong by the interstate for easy access for customers and semi's without destroying the community and devaluing neighborhoods and property. Mr. Schaff also beseeched the trustees to reject the SR 310 Corridor Study by MSI. On page 10 of the questionnaire, it was stated that MSI was mistaken when it included Smoke Road as a truck bypass in the graphics at the public hearing. One of the maps used and displayed was false and misleading and Mr. Scahaff feels this is deception. Another point on the questionnaire is the question of moving Wal-Mart to US 40 which he said biases the survey.

## **PUBLIC HEARINGS**

A. Jesse and Elizabeth Dawson 12055 Palmer Road from Low Density Residential District (R-1) to Agricultural District (AG)

At 7:20 p.m., Mr. George moved to open the public hearing, Knapp seconded and the vote in favor was unanimous.

Jesse and Elizabeth Dawson request their 5.056 acre property at 12055 Palmer Road be rezoned to agricultural to bring it back to the zoning it was before. The rezoning meets the requirements of the Agricultural District and the house and property will remain the same. LCPC's recommendation was to deny the rezoning and the Etna Township zoning commission recommended approval with a 3-2 vote.

Dan Bravard said the township needs green space and the rezoning should be approved.

At 7:26 p.m., Mr. George moved to close the public hearing, Knapp seconded and the vote in favor was unanimous.

Resolution 07-12-04-01: Mr. George moved to accept the recommendation of the zoning commission to rezone Jesse and Elizabeth Dawson's 5.056 acre parcel at 12055 Palmer Road from Low Density Residential District (R-1) to Agricultural District (AG). Knapp seconded and the vote in favor was unanimous.

B. Jesse and Elizabeth Dawson 10620 Tollgate Road from Low Density Residential District (R-1) to Agricultural District (AG)

At 7:28 p.m., Mr. George moved to open the public hearing, Knapp seconded and the vote in favor was unanimous.

Jesse and Elizabeth Dawson request their 5.02 acre property at 10620 Tollgate Road be rezoned to agricultural to bring it back to the zoning it was before. LCPC's recommendation was to deny the rezoning and the Etna Township zoning commission also recommended denial with a 3-2 vote.

Resolution 07-12-04-02: President Knapp moved to not accept the recommendation of the zoning commission to deny the rezoning and to grant the rezoning of Jesse and Elizabeth Dawson's 5.02 parcel at 10620 Tollgate Road from Low Density Residential District (R-1) to Agricultural District (AG). George seconded and the vote in favor was unanimous.

C. Freddie and Janice Haskett 10113 Taylor Road from Medium-low Density Residential District (R-2) and Local Business (LB) to Local Business

At 7:37 p.m., Mr. George moved to open the public hearing, Knapp seconded and the vote in favor was unanimous.

Mr. Haskett said the property has been zoned commercial since the 1950's. When the township approved the new zoning map in 1990, the entire property was not commercial. This is a correction of the zoning map. LCPC recommended approval and the zoning commission recommended approval by a 5-0 vote.

Dan Bravard said in the first zoning map in 1960, this property was local business and there was a convenience store at Palmer and Goings Roads. The maps later drawn were incorrect with the residential designation.

At 7:42 p.m., Mr. George moved to close the public hearing, Knapp seconded and the vote in favor was unanimous.

Resolution 07-12-04-03: Mr. George moved to accept the recommendation of the zoning commission to rezone Freddie and Janice Haskett property, 2.926 acres at 10113 Taylor Road from Medium-low Density Residential District (R-2) and Local Business (LB) to Local Business. Knapp seconded and the vote in favor was unanimous.
