The Etna Township Board of Trustees met on Tuesday November 17th, 2009 in the Etna Township Hall for the purpose of conducting a regular. The meeting was called to order at 1:30 p.m. by Vice-President Johnson. Chris Harkness led the prayer and Mike Waller led The Pledge of Allegiance. Roll call showed Trustees Jeff Johnson, and John Carlisle present. Trustee Dick Knapp and Fiscal Officer Tina Taylor were absent.

John Carlisle moved to adopt the agenda. Jeff Johnson seconded and the vote in favor was unanimous.

Public Comments -

Gary Burkholder 254 Trail East discussed the appointments for the boards. He presented minutes from a meeting in December of 2003. He feels the appointments should be made by the new board in January. He has requested Jeff Johnson and John Carlisle table these appointments until next year. He feels these appointments are important and will impact this community for the next five years. He may apply for one of the positions.

Reports

Roads

Mike Waller reviewed the road report that was presented. The Trustees discussed purchasing a plow for the road department to have a third truck available for snow removal. The plow is \$8,000.00. It was discussed purchasing a third truck. A trustee could operate the tractor with this plow and would not need a CDL. Mike will check into whether this plow will work on a smaller truck. This will be discussed at the next meeting.

The Orchard Glen Homeowners Association has requested using township post to mount block watch signs. These would be mounted on signs already provided in Orchard Glen. The Trustees discussed and Mike Waller will send a letter stating they can use the post, only two signs per post, and the Orchard Glen Homeowners Association is responsible for the sign.

John Carlisle moved that the Block Watch signs as requested by Orchard Glen be approved to be mounted on Etna Township owned poles, no more than two signs per pole, and all signs will be at the direction of Mike Waller Road Superintendent, and the block watch program is responsible for their signs. The township will maintain the post. Jeff Johnson seconded and the motion passed unanimously.

The road right-of-way permit process was discussed. The bond number will be written on the road rightof-way. A copy of the bond will not be necessary. Mike Waller will list conditions such as no open cuts when approving the right-of-way permit.

The high visibility clothing for the road department will be reviewed by John and discussed at the next meeting.

Resolution 09-11-17-01: Jeff Johnson moved to approve the following expenditures: Griffin stripping for \$825.50; Kleem Signs for 6 50% weight signs for a total of \$260.00; Waibel Electric for photocell for the flag pole for \$115.00; and up to \$500.00 for salt for the town hall with the vendor to be determined. John Carlisle seconded. Discussion: Laura Brown will call around for the best pricing on the salt and provide the information to John and Mike. The motion passed unanimously.

Jeff Johnson moved to approve Mike Waller's vacation request for November 25, 27, 30 and December 4th, 23rd, 24th, 30th, and 31st. John Carlisle seconded and the motion passed unanimously.

Zoning Report

Chris Harkness reviewed the written zoning report that was provided.

Chris discussed the winter newsletter. Chris suggested next year changing the newsletter to be a spring fall schedule. The next issue would start in early February and mail in March.
