The Board of Trustees met in the Etna Township Community Center on January 12<sup>th</sup>, 2010 for the purpose of conducting a special meeting. The meeting was recorded for the township records. The meeting was called to order at 12:00 p.m. by President Carlisle with Trustee Randy Foor present. Trustee Jeff Johnson and Fiscal-Officer Tina Taylor were absent. The Pledge of Allegiance was recited.
