RESOLUTION: 11-12-23-01 Trustee Carlisle moved the adoption of the following: Whereas, the Board of Trustees of Etna Township, Licking County, State of Ohio was petitioned for the provision of street lights in Russell Heights in 1996; Now, Therefore, be it resolved by the Board of Trustees of Etna Township, Licking County, Ohio: Enters into an agreement with Ohio Power Company to provide and maintain a street lighting district, within the Russell Heights subdivision; Therefore, be it further resolved that the township Fiscal Officer is directed to certify all American Electric Power Bills for the district, which were not previously billed to the property owners of the district, from 2006, 2007, 2008, 2009, and 2010, to the Licking County Auditor to be placed upon the tax duplicate of the property owners in the Street Lighting District; Therefore, be it further resolved to direct the township Fiscal Officer to certify all electric bills from 2011 forward, to the Licking County Auditor to be placed upon the tax duplicate of the property owners in the Street Lighting District. The motion was seconded by Trustee Johnson and passed by unanimous affirmative vote.
