The Etna Township Board of Trustees met on Tuesday, July 1, 2014 in the Etna Township Administration Building for the purpose of conducting a special meeting. The meeting was called to order at 6:30 p.m. by President Carlisle. Jeff Johnson led the invocation and Ron Tague led The Pledge of Allegiance. Roll call showed Trustees Jeff Johnson, Randy Foor, John Carlisle, and Fiscal Officer Walter Rogers present.

Trustee Johnson moved to adopt the agenda. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

#### Nuisance Hearings

##### 9816 Lynns Road

Rob Platte provided an overview of the nuisance. The property is owned by Patricia Jackson and she received notification of the violation. The property has not been mowed and Rob Platte recommends the Trustees declare it a nuisance. The property is vacant and Patricia Jackson's mailing address is in Florida.

**Resolution 14-07-01-01:** Trustee Foor moved as presented "Resolution to declare the property owned by Patricia Jackson, located at 9816 Lynns Road, in Etna Township, Licking County, Ohio, a nuisance." The motion was seconded by Trustee Johnson and passed by unanimous affirmative vote.

##### 11130 Smoke Road

Rob Platte provided an overview of the nuisance. The property is owned by Forest and Marsh Dupler and the property is vacant. The property owner was sent a certified letter but the township did not receive the signed card back. The property has been mowed in some areas but the entire property has not been mowed.

**Resolution 14-07-01-02:** Trustee Foor moved as presented "Resolution to declare the property owned by Forest or Marsha Dupler, located at 11130 Smoke Road, in Etna Township, Licking County, Ohio, a nuisance." The motion was seconded by Trustee Johnson and passed by unanimous affirmative vote.

Rob Platte stated this property has been abated.

##### 935 Pike Street

Rob Platte stated this property has been abated.

##### 9526 Watkins Road

Rob Platte provided an overview of the nuisance. The grass has not been mowed. The property is owned by Jetto Blevins. Mr. Blevins called today and said he would have the property mowed within two days. Rob Platte recommends the property be declared a nuisance with the standard seven day notice.




##### 878 Columbus Street
