Cemetery Survey

Trustee Foor explained that in 2012 the platting of the cemetery was approved. The previous quote is still valid.

Trustee Carlisle moved to allow Mr. Foor to proceed with the plotting, up to \$6,000 for the survey with Ackison. The motion was seconded by Trustee Johnson. Discussion: The quote did not include the caps. This is part of the approved amount. The motion passed by unanimous affirmative vote.

Trebel Gas Aggregation

Mr. Garrett was present to provide an overview of the gas aggregation. The gas is basically two parts, the actual product itself and the adder which is from the utility side. Mr. Garrett explained the difference between the fixed rate and the variable rate. The options are a guaranteed 7% discount off COH Adder, the fixed price, or NYMEX + Fixed Adder. Mr. Garrett stated most people are doing the fixed adder. The resolution is for retail natural gas.
