The Etna Township Board of Trustees met on Tuesday, May 1, 2018 in the Etna Township Administration Building for the purpose of conducting a special meeting. The meeting was called to order at 6:30 p.m. by President Carlisle. Jeff Johnson led the invocation and John Carlisle led The Pledge of Allegiance. Roll call showed Trustees Jeff Johnson, Randy Foor, John Carlisle, and Fiscal Officer Walter Rogers present.

Trustee Johnson moved to adopt the agenda as presented. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

Nuisance Hearings 10240 Watkins Road

The property owner is Alva Holley. John Singleton, Zoning Inspector, explained there are a number of junk motor vehicles located on the property. The township previously held nuisance hearings on the property. John Singleton could not verify if any of the vehicles had current tags.

Alva Holley was present and explained which vehicles had tags. Some of the vehicles do not belong to him. Seven vehicles are tagged.
