The Etna Township Board of Trustees met on Saturday, May 19, 2018 in the Etna Township Administration Building for the purpose of conducting a regular meeting. The meeting was called to order at 9:00 a.m. by President Carlisle. Charles Hagy led the invocation and Rick Ulery led the Pledge of Allegiance. Roll call showed Trustees Randy Foor, John Carlisle, and Fiscal Officer Walter Rogers present. Jeff Johnson was excused.

Trustee Carlisle moved to excuse Trustee Johnson from the meeting. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

Trustee Carlisle moved to adopt the agenda as presented. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

Trustee Carlisle moved to adopt the May 1, 2018 regular meeting minutes as presented. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

## **Public Comments -**

Mark Schaff of 7461 National Road requested an update regarding High Point Park. Trustee Foor is working on the items. Trustee Carlisle would like the park completed by the S.R. 310 grand opening in August.

### Nuisance Hearing Updates

10240 Watkins Road - Zoning Inspector John Singleton provided an update. Mr. Holley has been working on cleaning up the property. He had removed four cars on May 16, 2018. He had two more ready and this morning they were gone. He is extending the fence to the east.

Trustee Carlisle moved to extend until the first meeting in June. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

10620 Tollgate Road - Zoning Inspector John Singleton stated the certified has been mailed and the township has not received the card back.

## **Township Garage**

Rick Ulery was present to discuss the heating and cooling for the garage. He recommends doing the entire office space including the restrooms for \$43,800.00.

Trustee Carlisle moved to approve Mr. Ulery's proprosal, Advanced Aire Contract, for \$43,800.00 not to exceed \$45,000. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

Trustee Carlisle discussed the framing for the office area and mezzanine. This includes everything but the handrail for the mezzanine.

Trustee Carlisle moved to approve the contract to Timber Valley Contracting for \$47,823.00 and the purchase order not to exceed \$50,000 to include the handrail. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.

Trustee Foor discussed the concrete apron and the ballards at the garage and he presented a quote from Brown Construction for \$15,000 dollars.

Trustee Foor moved to contract with Brown Construction for \$15,000 to pour the concrete aprons and ballards at the garage. The motion was seconded by Trustee Carlisle and passed by unanimous affirmative vote.

Trustee Carlisle discussed the temporary electric and how they are going to get power to the building. The electrician said he would set the panel with the breakers and have it ready for \$2800.00 not including the direct bury line.

Trustee Carlisle moved approve up to \$5,000 to Glen Electric to put in the panel for the feed and the underground temporary electric line tying it into the existing garage. The motion was seconded by Trustee Foor and passed by unanimous affirmative vote.
